### Online Edition:

- All prices are in US Dollars. Payment in full must accompany each order.
- All subscription periods are calendar year (January 2010 – December 2010).

### Non-Member Individuals

- All prices are for a single, non-member personal subscription.
- **Who Can Access the Journal:** A non-member online subscription is an individual license for the personal use of the subscribing individual only. Sharing your user name and password is not permitted. If lab members, colleagues or students require access, please have your institution's librarian/information specialist contact ASBMB about purchasing an institutional subscription.
- **Activation Process:** Online access is provided by user name and password. Once your order and payment are received and processed by ASBMB, you will receive an email with instructions to activate your online subscription. You will select your user name and password during the activation process.
- **Access to Back Issues:** A non-member online subscription includes access to current year plus all available back issues online. Upon cancellation, access will be provided for years subscribed.

### Institutions

- All prices are for a single site/location. See below for information on obtaining a multi-site quote.
- **Who Can Access the Journal:** An institutional online subscription allows unlimited simultaneous Internet access by authorized users at one geographical site (see below) and does not include remote campuses, consortia or other forms of subscription sharing. **If your institution has multiple sites, each site must purchase a separate subscription or the institution must purchase a multi-site subscription\*.**
- **Definition of an Authorized User:** Authorized users are defined as employees, faculty, staff, students and consultants, whether on a permanent, temporary or contract basis, who are officially associated with the subscribing site and are permitted to access the secure network. Patrons of the institution's library facilities are also considered authorized users.
- **Definition of a Site:** A site is defined as an organizational unit that may be academic or nonacademic and may consist of several buildings that are administered jointly. For organizations with facilities located in more than one city, each city office is considered a different site. For organizations within the same city that are administered independently, each office is considered a different site. For example, each campus in the State University of New York system is considered a different site, each branch or office of GlaxoSmithKline is considered a different site and each institute of the National Institutes of Health is considered a different site. - **Activation Process:** Online access is provided by IP address. Once your payment is received and processed by ASBMB, you will receive an email with instructions to activate your online subscription. - **Access to Back Issues:** An institutional online subscription includes access to current year plus all available back issues. Upon cancellation, access will be provided for years subscribed.
